AND WHEREAS the parties hereby enter into this agreement on the terms and conditions appearing hereinafter;

NOW, THEREFORE, THIS AGREEMENT WITNESSED AND IT IS HEREBY AGREED BY AND BETWEEN THE PARTIES AS UNDER:

- The services of a person engaged by the Department shall be for a period not exceeding **one year** or till the candidates duly selected by Haryana Public Service Commission are available for regular appointment on these posts, whichever is earlier;
- The person shall be engaged for a fixed consolidated remuneration of Rs.25000/- per month;
- The services of the person so engaged shall hereafter cease on the expiry of the term without providing him/her any claim for the regularization of services or any other consequential benefit;

- The person so engaged shall not have any legal right claiming regularization of his/her service etc. in the Department where he/she has been engaged;
- The Department shall issue Identity Card on its own name to the person engaged for rendering services. The Department may refuse the entry into its premises of the person not bearing the said identity card and not being properly dressed;
- The services rendered by the person engaged by the Department shall be under the close supervision of the Department;
- It is understood between the parties hereto that only the Department shall have the right to take disciplinary action against the person so engaged;
- Neither the Department shall, under any circumstances, be deemed or treated as the employer of the person engaged for any purpose whatsoever, nor would the department be liable for any claim whatsoever of any such person;
- In case of the death of a person, his/her remuneration shall be paid to his/her legal heirs;
