Subject: Organisation of 41st State Livestock Show from 9th to 11th March, 2025 at Kurukshetra.

In reference to the subject cited above, it is intimated that the department is organizing 41th State Livestock Show at Kurukshetra Development Board, Kurukshetra from 9th to 11th March, 2025. Approximately, 1500 animals and 45,000 farmers are expected to visit this show. In order to make this event successful, following directions / guidelines are issued:

1. Dr. Sukhdev Rathee, Joint Director (HQ), O/o Director General, Animal Husbandry and Dairying, Haryana, shall be Nodal Officer for this Livestock Show.
2. The Veterinary Surgeons shall identify the best, true to breed, animals under different approved categories (**Annexure-I**) for participation in the show. The animals so identified by the Veterinary Surgeons shall be examined and finalized by a Committee of three officers chaired by the concerned Deputy Director.
3. The final list of participating animals under different categories should be sent to this office in the format enclosed at **Annexure-II** latest by **28th February, 2025**, positively, with a soft copy on the email ID's gdobranchahd@gmail.com and dg.ahd@hry.nic.in.
4. The district wise targets of minimum number of elite/ quality animal's participation in the show are enclosed at **Annexure-III**. Efforts should be made for the participation of maximum no. of quality animals.
5. To encourage the farmers to bring maximum number of elite animals to the show, financial assistance will be provided for transportation of animals to and from the Livestock Show as per the criteria given hereunder:

Distance in KM (from the village/ town of the farmer to the Livestock Show site)				
Up to 50 KM	51- 100 KM	101-150 KM	151-200 KM	> 200 KM
Rs. 1000 per animal/unit	Rs. 1500 per animal/unit	Rs. 2000 per animal/unit	Rs. 2500 per animal/unit	Rs. 3000 per animal/unit


Note: Each unit of small animals (sheep and goat) shall be considered as one large animal.

6. Green fodder, dry fodder, water and stay for the participating animals will be arranged by the department free of cost.

7. The attendants of the animals shall also be provided free food and accommodation in the scout tents during the Livestock Show.
8. The owners of the participating animals should be encouraged to bring them at the site of Livestock Show the day before the event starts i.e. 8th March 2025, by 4.00 PM, positively, so that the necessary registration formalities can be completed, well in time. No entry/registration will be permitted thereafter.
9. The Deputy Director shall personally ensure that all the animals participating in the Livestock Show from their district should be vaccinated against the major diseases and should have valid insurance.
10. The cattle and buffalos without 12 digit ear tag would not be allowed to participate in the livestock show.
11. The owners of the livestock participating in the show should be advised to bring physical copies of following documents with them for hassle-free disbursement of prize money/ financial assistance.
 - i. Aadhaar Card
 - ii. PAN Card
 - iii. Copy of bank pass book OR Cancelled cheque
 - iv. Parivar Pehchan Patra (PPP) ID
12. Maximum publicity of the event should be made, by all means of communications (radio, television, print/ digital/ social media, word of mouth), to motivate the farmers, women, young entrepreneurs and unemployed youth of the state to visit the State Livestock Show so that they may get an exposure to the plethora of opportunities available for them in animal husbandry and allied sectors.
13. Flex banners, as per the design shared by department, should be put on conspicuous places in all the veterinary institutions and the prominent common places in all the villages/ towns of your jurisdiction. The budget for the same shall be released soon.
14. The department would arrange 150 buses, each day, to bring the farmers, youth and women, willing to visit the show, to and from the show free of cost. The list of buses allocated for various districts is enclosed at **Annexure-IV**.
15. The Deputy Directors shall chalk out the routes of these buses in such a manner that maximum number of villages/towns of the district possible with the available number of buses may be covered. The routes should preferably be different on all the three days.
16. The Deputy Directors shall ensure that all the buses going to livestock show are full to their capacity and are manned with at least one or two officials/ officers of the department. The officer/official manning the bus will upload the photographs of the farmers sitting in the buses in the whatsapp group created especially for this purpose.

17. A flex banner, strictly as per the design shared by the department and having the name of the district, should be displayed in front of all the buses. The buses should **reach the event site latest by 10:00 AM** each day and should **not leave the event site before 3:30 PM**.
18. The Deputy Directors shall ensure that all the employees of the Department under their jurisdiction visit the Show in a rotational manner i.e. 1/3rd employees on each day, so that they may get exposure of the latest technologies and innovations in the field of animal husbandry.
19. The Deputy Directors shall ensure that all the budget allocated to them for various purposes is utilized timely and appropriately.




